	 To approve the re-establishment of the ICT Steering Committee as a formal committee of Council. To approve the constitution of the ICT Steering Committee, with the proposed membership consisting of three Council members and two External Members (subject to additional expertise being a criteria). Approve the following supporting documents (subject to agreed amendments): ICT Steering Committee Terms of Reference ICT Steering Committee Application Form ICT Steering Committee Internal Expression of Interest ICT Steering Committee External Application. Approved that expressions of interest be issued to Council members and that external membership opportunities be advertised. Approved a written decision, following the recommendations of the Nominations Committee, to enable the ICT Steering Committee to be established prior to December 2025. This will ensure the Committee can commence its work in advance of 2026 and provide timely oversight of the new Digital Strategy, which is scheduled to take effect from the beginning of that year.
