OPTICAL REGISTRATION BOARD CRITERIA FOR RESTORATION
TO THE REGISTER FOLLOWING REMOVAL ON REQUEST BYE-
LAW 2017

The Optical Registration Board, in exercise of the powers conferred on it by section 31 of the Health and Social Care Professionals Act 2005 (as amended), with the approval of the Health and Social Care Professionals Council, hereby makes the following bye-law:

1. (1) This bye-law may be cited as the Optical Registration Board Criteria for Restoration to the Register following Removal on Request Bye-Law 2017.

(2) This bye-law comes into operation on 28 March 2017.

2. (1) In this bye-law—

“the Act” means the Health and Social Care Professionals Act 2005 (Number 27 of 2005) as amended from time to time;

“the applicant” means a person who submits an application to the board for restoration to the register following removal on request;

“the board” means the Optical Registration Board established under section 26(1)(da) of the Act;

“register” means either the Register of Dispensing Opticians or the Register of Optometrists established and maintained by the Optical Registration Board under section 36 of the Act.

(2) In this bye-law any phrase introduced by the terms “including”, “include”, “in particular” or other similar expression shall be construed as illustrative and shall not limit the sense or meaning of the words preceding those terms.

(3) For the purposes of this bye-law, an applicant shall be deemed to have applied for restoration upon the date the board receives an application for restoration under paragraph 3(1) or paragraph 3(2) from the applicant accompanied by the relevant fee.

3. For the purposes of section 39(2)(c) of the Act, the board has determined that a person must meet the following criteria for restoration to the register:

(1) If an applicant applies for restoration within 6 months of the date of removal of his or her name from the register, an applicant must complete the appropriate restoration application form and submit it and the relevant fee for restoration to the board.

(2) If an applicant applies for restoration 6 or more months and within two years after the date of removal of his or her name from the register, an applicant must:

- (a) complete the appropriate restoration application form and submit it and the relevant fee for restoration to the board;
- (b) provide any details required by the board in relation to any occupation and/or employment (whether paid or unpaid) undertaken by the applicant during the period since their removal from the register;
- (c) in circumstances where an applicant engaged in the practice of any registered profession outside the State since their removal from the register, provide particulars regarding the applicant's practice of that profession outside the State as appropriate, and provide a certificate of good standing / current professional status or equivalent from the regulatory body in the country where he or she engaged in such practice, where appropriate; and
- (d) satisfy the board that the applicant is a fit and proper person to engage in the practice of the profession of dispensing optician, or the profession of optometrist as the case may be, and
 - (i) submit a fully completed and signed application for vetting disclosure (within the meaning of the National Vetting Bureau (Children and Vulnerable Persons) Act 2012 to 2016 (No. 47 of 2012)) permitting An Garda Síochána to furnish any and all information lawfully permitted;
 - (ii) in the case of applicants who have lived outside of the State for such periods of time as the board may specify, a certified copy of police clearance from the jurisdictions of previous residence (or such jurisdictions as the board may deem appropriate) and/or such other information as the board may from time to time determine in respect of such periods;
 - (iii) complete and sign a questionnaire together with such supplementary information as may be required, in a format satisfactory to the board as to health and character;
 - (iv) complete and sign a declaration that the applicant knows of no reason why their name should not be restored to the register; and
 - (v) complete and sign a declaration that the applicant has read, understood and agrees to comply with the Code of Professional Conduct and Ethics for Optometrists or the Code of Professional Conduct and Ethics for Dispensing Opticians as appropriate.

(3) If an applicant applies for restoration two years or more after the date of removal of his or her name from the register, an applicant must:

- (a) comply with the criteria set out under paragraph 3(2) of this bye-law; and
 - (b) complete a statutory declaration in such form as may be specified by the board from time to time.
 - (4) An applicant shall:
 - (a) verify any information or details contained in his or her application for restoration where required by the board;
 - (b) supply to the board any further information relating to the application for restoration where requested by the board and within such period of time as may be specified by the board;
 - (c) provide any information which is required in connection with an application for restoration to the register to be supplied by means of a statutory declaration where required by the board; and
 - (d) comply with such requirements of the board in respect of the education, training and continuing professional development of registered optometrists, or registered dispensing opticians as the case may be, as may apply from time to time.
 - (5) Without prejudice to any bye-laws which the board has made or may from time to time make pursuant to section 31(1) of the Act, the board reserves the right to require any person who:
 - (a) applies for restoration as an optometrist or dispensing optician to the appropriate register and has been engaged in the practice of the profession of optometrist, or the profession of dispensing optician as the case may be, outside of Ireland for two years or more (or such other period as the board may specify); or
 - (b) applies for restoration as an optometrist or dispensing optician to the appropriate register and has not been engaged in the practice of the profession of optometrist, or the profession of dispensing optician as the case may be, within Ireland for two years or more (or such other period as the board may specify);
- to comply with any bye-laws in respect of return to practice and/or such other requirements as the board may from time to time specify.
