ELECTION OF MEMBERS FOR APPOINTMENT TO THE DIETITIANS  
REGISTRATION BOARD (AMENDMENT) BYE-LAW 2024

The Dietitians Registration Board, in exercise of the powers conferred on it by section 31 of the Health and Social Care Professionals Act 2005, with the approval of the Health and Social Care Professionals Council, hereby makes the following bye-law:

1. (1) This bye-law may be cited as the Election of Members for Appointment to the Dietitians Registration Board (Amendment) Bye-law 2024.

(2) The Principal Bye-law and this bye-law may be cited together as the Election of Members for Appointment to the Dietitians Registration Board Bye-laws 2023 and 2024.

2. (1) In this bye-law “Principal Bye-Law” means the Election of Members for Appointment to the Dietitians Registration Board Bye-law 2023 (S.I. No. 357 of 2023).

3. Paragraph 7 of the Principal Bye-Law is amended in subparagraph (2) by substituting “23” for “24”.

4. The Election of Members for Appointment to the Dietitians Registration Board Bye-law 2016 (S.I. No. 387 of 2016) is revoked.
