Category 1: Registrant engaged in the practice of the profession

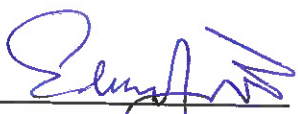

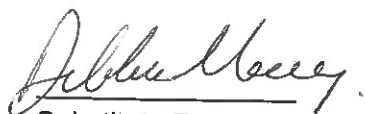
